LEGISLATURE MEETS IN SPECIAL SESSION; GOVERNOR SIGNS 5 BILLS INTO LAW

The New Mexico Legislature convened in Santa Fe October 1–2 for a special session called by **Governor Michelle Lujan Grisham** to address the state-level impacts of the recently enacted federal **H.R. 1 – One Big Beautiful Bill**. In her "call" to legislators, the Governor outlined 11 specific items for lawmakers to consider, including proposals related to health care funding, vaccination standards, and court

competency procedures. Among the issues listed were:

- Expanding the Rural Health Care Delivery Fund to support providers and facilities in high-needs shortage areas and to stabilize existing services;
- Adjusting eligibility for the state's health insurance exchange;
- Updating immunization rules for children and adults;
- Appropriating funds in response to federal budget cuts and for several state agencies; and
- Funding the study and implementation of interstate medical licensing compacts.

During the brief session, legislators introduced 11 bills. The top priority for NMHA was Senate Bill 1 - Health Care Grants and Stabilization, which expands the state's Rural Health Care Delivery Fund (not to be confused with the new federal Rural Health Transformation Program) to help sustain essential health care services at risk of closure or reduction. The bill also extends eligibility to providers located in HRSAdesignated high-needs geographic health professional shortage areas. Before the session began, draft language surfaced that would have excluded for-profit hospitals and providers from accessing the Fund and required disclosure of detailed financial and governance information in applications. Among many issues, we were concerned that his could impact those hospitals' ability to access funds as part of the federal Rural Health Transformation Program if the state placed those dollars in the existing Rural Health Care Delivery Fund. Thanks to swift advocacy by NMHA, our partners, and you and your government relations teams and lobbyists, this language was removed prior to introduction. Several legislators raised concerns about the omitted for-profit language, including Senator Katy Duhigg on the floor of the Senate. In response, Health Care Authority Secretary Kari Armijo noted during committee hearings that applicants for stabilization funds will still likely need



to provide robust financial documentation to demonstrate their inability to continue providing the services without state support.

The other four bills that were signed into law (no bills were vetoed) are:

- House Bill 1 General Appropriations
- House Bill 2 Health Care Coverage Changes (expands the uses of the Health Care Affordability Fund to support individuals losing premium tax credits for health insurance exchange plans)
- Senate Bill 2 Criminal Competency
- <u>Senate Bill 3</u> Immunization Rules & Recommendations (see <u>Source NM article</u> for more information)

House Bill 1 includes \$100,000 to "implement interstate compacts regarding health care professionals." No other legislation about interstate compacts advanced.



GOVERNOR LUJAN GRISHAM REAFFIRMS SUPPORT FOR MEDICAL MALPRACTICE REFORM, SENATE REPUBLICANS HOST MALPRACTICE TOWN HALL

Governor Michelle Lujan Grisham repeated her support for addressing medical malpractice reform during a recent interview on NMPBS's *New Mexico in Focus*. The Governor announced that she intends to include medical malpractice on the "call" for the upcoming 2026 Legislative Session, allowing lawmakers to take up the issue during the 30-day session. She also voiced her support for New Mexico's participation in various interstate medical licensure compacts. Watch the Governor's remarks here.

CARA WORKGROUPS FORMING: REQUEST TO PARTICIPATE ON BEHALF OF HOSPITALS BY OCTOBER 21

CARA Workgroup Application

As the implementation of SB42 moves forward the **HCA** is seeking community and other stakeholder input and will be convening 6 distinct workgroups to inform the Comprehensive Addiction and Recovery Act (CARA) Program redesign. The NMHA strongly encourages hospital participation in this process. The CARA Workgroups are as follows:

CARA Navigator Work Group - this work group will create processes for CARA Navigators to access information about members in the CARA Program who are identified prenatally, intrapartum, postpartum or in the emergency



department and connect with these individuals to assist with fulfilling the plans of safe care. The CARA Navigators will be responsible for creating touch points and documentation as well as ensuring that referrals are completed via closed loop processes.

CARA Hospital Presence Work Group - this work group will create processes to act as a hub among the following stakeholders: facilities, CARA Navigators, CYFD, and MCOs. The processes must ensure timely Plan of Safe Care initiation and Safety Plans for Children in state custody situations as well as compliance with state and federal regulations.

CARA Plan of Safe Care (POSC) Work Group - this work group will update the existing POSC template and expand it to include record of documentation for CARA Navigator touch points and all interdisciplinary actions. This work group will also define 'compliance' metrics and outcomes for the POSC. This work group will also draft patient information and informed consent documents to be standardized for use in all health care settings in the state.

CARA Training Work Group - this work group will work with BHSD to identify screening tools, create trainings and protocols for health care providers across the state. This work group will also be responsible for aligning trainings with national standards for perinatal people with substance use disorders, as well as training providers in screening newborns.

CARA POSC Portal Work Group - this work group will be a cross-state agency team responsible for researching and selecting a portal vendor, creating policy relevant to the portal as required by Senate Bill 42, influencing components of the portal, and holding testing sessions with providers to elicit feedback. This work group will create training for providers on how to use the portal.

CARA Tribal Work Group - this work group will be responsible for oversight of interventions to ensure cultural safety, as well as ensuring timely communications with all Tribal Nations about individuals enrolled in a CARA POSC.

The HCA invites robust community input, from those with lived experiences and knowledge from the various and diverse New Mexico communities. Work groups will meet remotely (online) approximately every 2 weeks until summer 2026.



Changes to Allowable Telehealth Services in Medicaid

During the Covid-19 public health emergency, the federal government expanded allowance of telehealth services via audio-only platforms. The extension of this federal allowance for audio-only telehealth service ended September 30, 2025, with the exception of behavioral health services. The allowance to use audio-only telehealth platforms
